

1	The above results were reviewed by the Audit Committee and approved by the Board of Directors in their meeting held on 29th June 2020
2	The Company adopted Indian Accounting Standard ("Ind AS") from April 1, 2017 and accordingly these financial results have been prepared in accordance with the recognition and measurement principles laid down in Ind AS 34 Interim Financial Reporting prescribed under Section 133 of the Companies Act, 2013 read with the relevant rules there under and in terms of the Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and SEBI Circular No: CIR/CFD/FAC/62/2016 dated July 05, 2016.
3	The Stand alone results of the Company are available on the Company's website www.terraformmagnum.com and also available on BSE Ltd. respectively.
4	The outbreak of Coronavirus (COVID-19) pandemic globally and in India is causing significant disturbance and slowdown of economic activity. In many countries, businesses are being forced to cease or limit their operations for long or indefinite period of time. Measures taken to contain the spread of the virus, including travel bans, quarantines, social distancing, and closures of non-essential services have triggered significant disruptions to businesses worldwide, resulting in an economic slowdown.
5	COVID-19 is significantly impacting business operation of the companies, by way of interruption in production, supply chain disruption, unavailability of personnel, closure / lock down of production facilities etc. On 24th March 2020, the Government of India ordered a nationwide lockdown for 21 days which further got extended till 3rd May 2020 to prevent community spread of COVID-19 in India resulting in significant reduction in economic activities. Further, during March/April 2020, there has been significant volatility in property rates, resulting in reduction in property rates.
6	During the period under review, the company has agreed to assign/transfer rights in the disputed property / land at Kandivli East, for a sum of Rs.3050.00 lakh. Out of total consideration the company has received Rs. 2550.00 lakh. The matter with respect to the property is pending with the Honorable Bombay High court with respect to one litigation and some other litigations are pending with Bombay City Civil Court. Since the performance obligation with respect to assignment/transfer of rights of the said property is pending no revenue is recognised for the year ended / quarter.
7	Figures for the quarter ended 31st March, 2020 and March, 2019 are the balancing figures between audited figures in respect of the full financial year and published year to date figures to the third quarter of year ended 31st March, 2020 and March 31, 2019 respectively.

We have audited the accompanying statement of standalone financial results of TERRAFORM MAGNUM LIMITED (the company) for the, Quarter and year ended March 31, 2020 (“the Statement”), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (“Listing Regulations”).

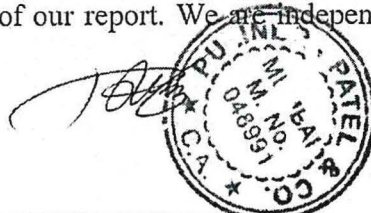
In our opinion and to the best of our information and according to the explanations given to us, the Statement:

(i) is presented in accordance with requirements of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended in this regard; and

(ii) gives a true and fair view in conformity with the recognition and measurement principles laid down in the applicable Indian Accounting Standards and other accounting principles generally accepted in India of the net profit and other comprehensive income and other financial information of the Company for the quarter and the year ended March 31, 2020.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (“SAs”) specified under section 143(10) of the Companies Act, 2013 (“the Act”).
